Qualification:

- For the post of **General Duty Medical Officers**: MBBS (In accordance with the regulation made by the Medical Council of India in 1998 published in part-III, section 4. And one year House-staff-ship, relaxation will be given in case of retired Medical officers.
- For the post of **Specialist Medical Officer** (To be utilized as Gynaecologist/ Paediatrician) : MBBS degree (In accordance with the regulation made by the Medical Council of India in 1998) and post graduate degree or diploma in the subject concerned required from the Universities of West Bengal or in accordance with the regulation made by the Medical Council of India and included in the first or Second or Third schedule of the Indian Medical Council Act 1950 (102 of 1950) or training in the subject concerned from any recognized institute.

AGE limit:

No age limit, but candidates should be physically fit enough to attend BPHC/PHC daily.

Monthly contractual Remuneration :

- For General Duty Medical Officer – Rs. 28000/- per month.
- For Specialist Medical Officer- Rs. 32000/- Per month.

1. The appointments would be on purely contractual basis for a period not exceeding one year renewable at end of term subject to satisfactory performance.
2. All candidates should be registered as medical practitioner with the West Bengal Medical Council/Medical Council of India.
