Dr. Saumitra Mohan, IAS, District Magistrate, Birbhum presided over the meeting.

At the outset of the meeting D.M, Birbhum read out the previous meeting's minutes dated 07/01/2011 and feed back thereof.

Ld. Public Prosecutor has obtained report from most of the Panel A.P.Ps of the District in respect of pending cases with the names of course and nature of cases.

Equal distribution of the cases among the Panel A.P.Ps have not been made which would be made very soon by the Ld. P.P. .

Performance report of the Panel A.P.P.s and Asstt. A.P.P.s of Rampurhat and Bolpur Court are not received upto this date .

6(Six) Panel A.P.P.s out of 13(Thirteen) of Sadar Sub-Division have not furnished their performance report for the month of Jan'2011 as per minutes of meeting dated 07/01/2011.

Investigating Officer of the concerned cases are not produced CD in time to the concerned Panel A.P.P.s. Witnesses are not also produced by the concerned Police Station before the date of case to brief the case hoistory by the P.P./ Panel A.P.Ps.

Presence of I.O. is highly required at the time of trial. In this connection, S.P. assured that he will discuss the matter with the I.C. and O.C.s of the P.S. in the next meeting.

After discussion the following decisions were taken in the meeting:-

- 1) Equal distribution of cases is to be made among the Panel A.P.P.s by the Ld. Public Prosecutor, Birbhum very soon and a report in this respect should be furnished by Ld.P.P. to A.D.M. (G).
- 2) Similar monthly meeting will also be held in this connection in the Sub-Divisional level and Quarterly meeting in the District Head Quarter will be held with all A.P.P.s and A.G.P.s of the District.
- 3) Show cause notice will be issued against the Panel A.P.P.s of Sadar Sub- Division who have not furnished their performance report for the month of Jan'2011 within 07/02/2011. Similar action will be taken from the end of S.D.O. Rampurhat and Bolpur.
- 4) I.O.s of the concerned cases should produce the CD to the concerned Panel A.P.Ps or P.P. in time and they will render all possible help to defend the case. S.P., Birbhum will look into the matter.

- 8) The Next monthly meeting will held on 15/03/2011 at 03: 00 P.M. in the Conference Hall of Prashan Bhaban which will be presided over by the District Magistrate, Birbhum.
- 9) The performance report of the Panel A.P.P.s should be obtained before the meeting by A.D.M. (G) to review their performance.
