Sealed Tenders are hereby invited by the undersigned on behalf of this Panchayat Samiti from the resourceful bonafide contractors/Registered Labour Co-Operative Societies / Registered Engineers' Co-Operative Societies for the undermentioned works. Quantity of any item may vary upto 20% for which no change of rate will be allowed. **APPLICATION FOR TENDER PAPER will be received upto 2:00 p.m. on 25.11.2011** with self attested copies of all related papers such as Sale Tax / VAT , Income Tax P.Tax clearance certificates and payment certificate supported with work order as credential (60% of the amount put to tender of similar nature of work completed since the financial year 2007-2008) issued by the Central Govt./State Govt./Govt. undertaking Concern . **It is further to note that Original papers shall have to be shown at the time of purchasing of Tender Forms on 29.11.2011 before the TENDER SELECTION COMMITTEE, if desires for cross checking .**

Tender form will be sold upto 2:00 p.m. on 29.11.2011 from the office of the undersigned. Tenders will be received upto 1:00 p.m. on 01.12.2011 BY DROPPING IN THE TENDER BOX WHICH WILL BE KEPT AT THE OFFICE OF THE UNDERSIGNED AS WELL AS IN ONE ANOTHER TENDER BOX WHICH WILL BE KEPT AT THE OFFICE OF THE SUB-DIVISIONAL OFFICER OF SURI(SADAR) SUB-DIVISION AT FIRST FLOOR OF THE ADMINISTRATIVE BUILDING AT SURI,BIRBHUM and those will be opened on 01.12.2011 AT 3:00 P.M. in presence of the intending Tenderers. 2.0(Two)% of the amount put to tender shall have to be deposited as earnest money by way of **Bank Draft only** & to be made payable in favour of the **“Executive Officer, Dubrajpur Pandhayat Samiti”**. Exemption will be imposed for labour co-operatives only regarding submission of earnest money.

Tender without earnest money will summarily be rejected. Tenderers shall have to write their names & address and name of work with Sl. No. on the envelopes otherwise the envelopes may not be opened at all.
