



Revised Tender Notice

Sealed tender in form of quotation are invited by the BDO & PO NREGA Suri-I Dev. Block from the resourceful bonafide contractors / agencies / owner of JCB, Dumper for the following work and having ST, IT & PT upto date clearance certificate.

Attested Xerox copy of ST, IT, PT clearance must be submitted along with the quotation (not returnable).

Quotation will be received upto 2:30 pm. on 22/07/09 and will be opened at 3:00 pm. on 22/07/09 in presence of the intending quotationer, if any. Quotations are to be deposited in the tender box kept for this purpose in the office chamber of the undersigned. No conditional quotation will be allowed in any case.

Quotationer must quote rate per 100 cft including loading, unloading and carriage etc. Quotationer should inspect the site and acquaint themselves with the difficulties and peculiarities if any. Successful quotationers will have to deposit Earnest Money of Rs.20,000=00 (Rupees Twenty thousand only) by bank draft on PO & BDO, Suri-I Development Block.

No interest can be claimed under any circumstance whatsoever for the Earnest Money Deposit. The work is to be started within 7(Seven) days from the date of work order and shall be completed within stipulated date mentioned in the work order.
