For and on behalf of the Govt. of West Bengal, the District Controller, Food & Supplies, Birbhum, invites open Tender through prescribed form from last 3 years experienced regarding handling of food grains in the state Govt./Hired Godowns, bonafide and financially solvent person/persons for appointment of Handling Contractor by the State Govt. for loading unloading of food grain bags from/into Railway wagons, Trucks etc. stacking food grains bags bagging, rebagging, weighment, standardization, cleaning of food grains, periodical physical verification etc. at the State Govt. Food storage godowns located at **Sainthia, Suri, Ahmedpur, Mollarpur, Rampurhat, Murarai, Chatra, Lohapur, Tantipara and Bolpur** during the period upto September 2011, with provision for subsequent extension of further 6 (six) months with the same terms and conditions in two phases of 3 (three) months each, if so considered necessary by the employer.

The sealed tenders along with Earnest money of Rs 5000/- (Rupees Five Thousand) only through Demand Draft /D.C.R drawn in favour of the District Controller, Food & Supplies, Birbhum, payable at the State Bank of India, Suri Branch, Birbhum, will be received on 16.09.2011 to 23.09.11 upto 5:00 PM in the sealed tender box in the chamber of the undersigned.

Tender forms not accompanied by the earnest money shall be summarily rejected. The successful tenderers shall have to be obtained license under the provisions of Contract Labour (Regulation and Abolition) Act, 1970, or exemption if eligible there under from the competent Authority before starting the work.

This may also be noted that the provisions of Employees Provident Fund Act, 1952, where applicable, shall be strictly observed by the appointed Contractor.
