Tenders will be received up to **3.00 PM on 10/03/08** and will be opened **on the same date at 3.30 P.M.** in presence of intending tenderers. 2% (Two percent) of the tender amount shall have to be deposited as Earnest Money only by Bank Draft and made payable to "**Birbhum Zilla Parishad**" at Suri.


